How much do solar panels cost in Georgia?

Most Georgian households, given the state's warmer climate and consequently higher energy consumption, lean towards a 10-kW system to meet their energy needs. And the average price tag for solar panels in Georgia? About \$3.74 per watt.

What solar incentives are available in Georgia?

Here are solar incentives for Georgia residents: Federal solar tax credit (ITC): The federal government offers a 26% solar panel tax credit when investing in solar panels for your home. The credit is scheduled to decrease in 2022 and eventually disappear if Congress doesn't renew it. So be sure to buy your panels before the credit is gone.

How much energy does Georgia get from solar panels?

How much does a 5 kW solar system cost in Georgia?

While a 5 kW system will only cost you \$13,173 in Georgia, doubling the system size effectively doubles the price, so you'll pay about twice that for a 10 kW system.
