Curiosity and interest in green energy spurred Kimto invest in his first wind turbine in 2000, and with a background as an accountant with more than 20 years of solid legal experience, he founded Momentum Energy in 2005. Throughout the 1970s and 1980s, investing in wind turbines was reserved for farmers and environmental idealists.

Is momentum a game-changer for the wind industry?

In 2018, Momentum was the first in the world to successfully complete a technical lifetime extension of an offshore wind farm on Gotland in Sweden (Link to Wind farm Bockstigen case), an achievement that resonated with the industry and proved to be a game-changer for Momentum.
