When did EEX start offering emissions contracts?

When did EEX become Deutsche Boerse?

In May 2015, EEX moved in the agriculture space, offering contracts on potatoes and dairy products, thus marking EEX as the commodities exchange for Deutsche Boerse. The exchange grew through its 2017 purchase of Nodal Exchange, which marked EEX's entrance into the US market.
