

What does EnerSys do?

EnerSys is a stored energy systems and technology provider for industrial applications. The company manufactures reserve power and motive power batteries, battery chargers, power equipment, battery accessories and outdoor equipment enclosure systems.

Where is EnerSys headquartered?

It serves customers in the telecom, security systems, renewable, uninterruptible power systems, industrial and other sectors across North America, South America, Europe, the Middle East, Africa and Asia Pacific. The company has manufacturing facilities in various parts of the world. EnerSys is headquartered in Reading, Pennsylvania, the US.

Does EnerSys sell batteries?

EnerSys also manufactures and sells related DC power products including chargers, electronic power equipment and a wide variety of battery accessories. In June, the company signed a memorandum of understanding with Verkor SAS to explore the development of a lithium battery gigafactory in the US. In April, the company acquired Industrial Battery and Charger Services Limited. These industries include medical, aerospace and defense systems. With the Alpha acquisition, EnerSys expanded its portfolio to become a fully integrated DC power and energy storage system and technology provider for broadband, telecom and energy storage systems.

EnerSys, in 2000, acquired Yuasa's industrial division. The Hawker Group merged with EnerSys in 2002. In 2002 EnerSys acquired Energy Storage Products Group of Invensys for \$505 million. Acquired in 2011 in the United Kingdom. Acquired in March 2011 they made Lead and Nickel based batteries for motive and reserve power markets in Greece.
