The corporate tax rate in St Kitts and Nevis is 33% and is applied to the company's net profit. St Kitts and Nevis tax residents pay corporate taxes on their global income, while non-tax residents pay only on the income earned in St Kitts and Nevis. The corporate tax is paid at the end of the fiscal year. The due date is 3.5 months after it.
