

Should Germany return to nuclear power?

Germany is the only country to have a complete phase out of its nuclear plants. The head of the International Atomic Energy Agency (IAEA) said in an interview late on Wednesday that it was "rational" for Germany to return to nuclear power even though the country's phase out was completed in 2023. "I think it's a logical.

Is Germany embarking on a new era of energy production?

"We are embarking on a new era of energy production," said Steffi Lemke, a Greens member and Germany's federal minister for the environment and nuclear safety, in a CNN interview following the plant closures. Nuclear energy is a controversial topic in most places, but Germany is notable for its historic antipathy toward the technology.

What is Germany's energy transition?

Germany's now-famous "Energiewende" (translated as "energy transition" or even "energy revolution"), however, has from its earlier inception sought to shift away from both carbon-intensive as well as nuclear energy to predominantly renewable alternatives.

Can Germany restart a nuclear reactor?

Germany can restart at least eight nuclear reactors, some within 9 months. Continuing the use of nuclear energy is supported by 67% of Germany and would stem losses in Germany's industrial production. No insurmountable hurdles have been identified. However, pragmatism and proactiveness is required.

Why did Germany leave nuclear power?

One of the main justifications for Germany's departure from nuclear power is the planned transition to renewable energy sources--a key reason why the Green party has supported the decommissioning of nuclear power plants.

Will Germany reactivate nuclear power in 2022?

Indeed, the three political parties in Germany's governing coalition did agree by late spring 2022 on reactivating coal plants. Nuclear power, in contrast, had become a polarizing issue for the cabinet, with leaders of the co-ruling Green Party most opposed to keeping the final three reactors.
