The Collective Investment Schemes Act 2008, which came into operation on 1 August 2008, contains the statutory framework for the regulation and governance in the Isle of Man of collective investment schemes. These are more commonly known as unit trusts, mutual funds or open-ended investment companies. The Act sets out four classes of Scheme:
