Yemen is a focus country for Kuwait Energy. Block 5 and 43 are producing assets and have established infield infrastructure and sales channels(1). . As at 30th June 2015, Kuwait Energy legally exited from block 43. Exploration opportunities exist in all blocks. All blocks operated under PSCs. Development plan focused on Block 5.
