Does Pan American own horizon lithium & FMS lithium?

Simultaneously, Pan American announced its decision to terminate the option agreement with Horizon Lithium and FMS Lithium, which would have allowed the company to earn a 100% interest in the Horizon property in Esmeralda County, Nevada.

How much lithium does Iran have in reserves?
