

Is there a market for roof-top solar energy systems in Timor-Leste?

Australia's Market Development Facility (MDF) and ITP Renewables conducted an assessment of the potential market for roof-top solar energy systems in Timor-Leste.

Will Woodside send Sunrise gas to East Timor?

Woodside previously preferred the option of sending the Sunrise gas to Darwin as there are two existing LNG plants in the region, namely the Santos-led Darwin LNG facility and the Inpex-operated Ichthys LNG plant. However, O'Neill revealed in November last year that the firm is willing to consider sending the gas to a new LNG plant in East Timor.

Is Timor-Leste a good country for solar energy?

Timor-Leste has a high-quality solar resource. The global horizontal irradiance in Dili is higher than on the east coast of Australia, where the solar market is mature and installation costs are higher. The cost of electricity in Timor-Leste for commercial and industrial consumers is high compared to ASEAN countries.

Does Woodside Energy support Timor-Leste's Sunrise Project?

"Woodside Energy understands, respects, and wholeheartedly supports Timor-Leste's aspiration for Sunrise to deliver real benefits to its people and we are very excited to collaborate on this important next step for the project," the CEO said. O'Neill did not provide any additional information.

Where is Woodside Oil located in Timor & Timor?

O'Neill did not provide any additional information. Woodside operates the Greater Sunrise fields, located about 450 kilometers north-west of Darwin and 150 kilometers south of East Timor, with a 33.4 percent stake. The nation's oil company Timor GAP has a 56.56 percent stake while Osaka Gas has a 10 percent stake.

Which development is best for Timor-Leste?

The studies will include an evaluation of which option provides the most meaningful benefit for the people of Timor-Leste. The Sunrise development, located approximately 450 km northwest of Darwin and 150 km south of Timor-Leste, comprises the Sunrise and Troubadour gas and condensate fields.
