

Trinidad and Tobago has a new energy

What is the energy policy of Trinidad and Tobago?

The Government of Trinidad and Tobago is currently developing a national energy policy green paper that recognises renewable energy's (RE) combined with energy efficiency (EE) and utilisation of compressed natural gas in the transportation sector, inter-alia, as important strategies for the promotion of sustainable development of the nation.

Does Trinidad and Tobago have a power generation capacity?

However, Trinidad and Tobago power generation capacity surpasses its current demand (Inter-American Development Bank, 2015), which provides avenues for energy storage through low carbon H₂, MeOH and NH₃ production directly within the local downstream supply chain.

What makes Trinidad and Tobago unique?

Trinidad and Tobago is heavily dependent on its oil and gas reserves (Fig. 3), petrochemical and other hydrocarbon related downstream industries (Indar, 2019). Thus, the country is unique amongst SIDS and must maximise its benefit from these natural resources, in terms of energy production.
