

EDF Group's first battery storage project in North America, reached commercial operation on December 20, 2015. The energy storage system, located in McHenry County, Illinois, added 40 MW of flexible capacity (20 MW nameplate) to the PJM Regional Transmission Organization (RTO) and will participate in both the regulation and capacity markets.
