

Is the energy mix of the UAE diverse?

The UAE, despite having the world's seventh largest proven oil reserves and the seventh largest natural gas reserves, has taken aggressive action to diversify its energy mix and economy.

What does the UAE Ministry of energy do?

The Ministry aims at achieving security, sustainability and competitiveness of the sectors of energy, water and mineral wealth. It targets reducing greenhouse gas emissions in the country by developing and following up on strategies such as the preparation of the UAE National Energy Plan 2050, and the Water Security Strategy 2036.

How many emirates are there in the UAE?

There are seven emirates, each with its own Ruler: Abu Dhabi; Ajman; Dubai; Fujairah, Ras Al Khaimah ("RAK") (which joined the federation in 1972); Sharjah; and Umm Al Quwain. The UAE has both federal level and emirate level laws and regulations that govern its renewable energy regime.

Where in the UAE can wind energy be used?

In the east of the UAE, both SEWA and FEWA are well positioned to take advantage of wind energy. Of particular note is the development of building floating wind turbines⁴¹ which would allow a fixed mooring just off the coast of Fujairah (FEWA area) or Sharjah with good connections into the Emirates National Grid in Fujairah.

How can RE capacity be built in the UAE?

Building large-scale plants through competitive tendering has been the primary mechanism for building RE capacity in the UAE, using project finance on a build-own-operate (BOO) model, based on long-term off-take agreements. Recent tender results have generated record-breaking tariffs in quick succession.

What are the Emiratisation requirements in the UAE?

There are a number of requirements, including for foreign employees to hold a valid employment visa and work permit. In addition, Emiratisation is increasingly significant and there are both statutory and contractual requirements to both hire and train UAE nationals.
