

What is Vietnam Electricity Corporation?

Vietnam Electricity Corporation was established by decision No.562/QD-TTg dated October 10, 1994, by the Prime Minister based on the reorganization of the units of the Ministry of Energy; being organized and operated under the Charter attached to Decree No. 14/CP dated Jan 27, 1995, of the Government.

When was Vietnam Electricity Group established?

On June 22,2006,the Prime Minister of the Government issued the decision No. 147/QD-TTg approving the pilot scheme to establish the Vietnam Electricity Group and the decision No. 148/2006/QD-TTg on the establishment of the parent company - Vietnam Electricity Group.
